


Leading the charge in the decarbonisation of the UK rail network

## In choosing ARQ, you are choosing to do things differently.

Decarbonisation is a huge focus for the rail industry over the next 30 years, as the UK government aims to remove all diesel-only trains by 2041, with a legally binding commitment to net zero by 2050. It has been recognised by the industry that together, we must do more to be part of the solution to climate change.

Network Rail estimates that to decarbonise the UK rail network completely, 13,000 single track kilometres (approximately 450km per year) of track will need to be electrified by 2050 to achieve net zero. However, it has been identified that from 2019-2020 only 251km was electrified.

To help achieve these targets a new collaborative partnership, comprising of three leading rail companies within the Renew Holdings Group, has been launched.





The ARQ partnership, which comprises of AmcoGiffen, Rail Electrification Ltd (REL) and QTS, provides a truly integrated self-delivery model for the UK rail network as it moves closer to achieving these electrification and decarbonisation targets.

This partnership will play its part in meeting the challenges set to industry by Network Rail in response to the UK decarbonisation agenda within the UK rail infrastructure.

Collectively, each of the businesses has been providing expert services in their respective trade to enable electrification programmes across the UK throughout Control Periods 5 and 6.


